Fantastic's Inc. Bowling Club - Tournament Rules

1 This tournament will be certified by USBC (# 10260) and operate under USBC rules.

All bowlers must be current member of USBC. A bowler who is not certified this season can purchase a certification card the day of bowling for \$21.00. A bowler who enters the tournament without a current paid membership will cause a forfeit of his/her team scores and entry fee.

2 **TEAM ENTRY**: Total cost is \$150.00 (\$30.00) per bowler. \$65.00 is bowling fees and expenses and \$85.00 prize fund per team entry. 100% of prize fee returned. The \$3,000.00 first place prize is based 90 teams, pay off will be determined by number of entries and at least 1 in 10 entries will cash.

3 Teams must consist of any combination of 3 & 2 (men or women.)

4 **OPITIONAL Unisex Open Singles Tournament** entry fee is \$10.00 per bowler - Prize fund \$8.00 - Tournament Expense \$2.00, 100% of prize fee returned. The \$240.00 first place prize is based 75 entries, pay off will be determined by number of entries and at least 1 in 10 entries will cash.

5 **OPITIONAL Unisex Senior Singles Tournament** bowlers must be at least age 50 or older. Entry fee is \$10.00 per bowler - Prize fund \$8.00 - Tournament Expense \$2.00, 100% of prize fee returned. The \$240.00 first place prize is based 75 entries, pay off will be determined by number of entries and at least 1 in 10 entries will cash.

6 Late bowlers will receive zero for frames missed. (No Refunds!)

7 **AVERAGES**: All bowlers will list the highest average from the 2012-2013 season based on a minimum of 36 games (not including summer averages). The 10 pin rule is not in effect. Reporting correct averages is the responsibility of the team captain. Failure to report correct averages could result in the team being eliminated from the tournament. A bowler who has not established a yearbook average will be allowed to bowl but will enter the tournament with a 220 average. It is the right of the Tournament Director to re-rate any bowler that is determined to be a detriment to the life of this tournament and reject any entry. BEWARE!!!!!!

8 **HANDICAP**: Teams will receive handicap of 80% from 1100. An individual bowler who has an average above 220 will receive no handicap, but will not lose pins.

9 **ELIGIBILITY**: No PBA/PWBA current member or member from the past 5 years will be allowed to bowl.

10 Rule 319e will not apply. (Average adjustment requirement)

11 Rule 319d will not apply. Bowlers need not report Tournament prize winnings.

13 All substitutions must be made at least one (1) hour before the bowler is scheduled to bowl. If the Bowling Coordinator does not have the change at least one (1) hour before the scheduled bowling time, the substitute will not be allowed to bowl. The only exception to this rule is when the Bowling Coordinator deems it an emergency and the change could not have been made in the allotted time.
